Note: If a Beginner User is trying to access Advanced features like Premium Intraday, SMARTRobie® in-app alert/notification will notify Users that they are using Advanced investor features.

The User of SMARTRobie® shall declare his/her own Investment profiling which is made available in our SMARTRobie® Mobile Application. This declaration places the responsibility of truthfulness upon the User.

TradeVSA shall not be held responsible to any User for any false declarations made by the User.

Any changes or amendment on the advisor strategy to be communicated to all Users via email, in-app notifications or other similar channels. Upon relying on our infrastructure provider, AWS, which offers 99.90% availability, we are committed to ensuring that SMARTRobie® is available 99% of the time excluding scheduled maintenance. If our service availability falls below this commitment, we will compensate our Users in the form of credit points. For every one-hour unavailability in SMARTRobie®, we shall compensate 1 credit points (or RM0.10).

### **13.0 Use / Limitation of Algorithm**

We disclose the following use/limitation of Pentagon Guider® Algorithm in SMARTRobie® app.

- Reduced Effectiveness in Trendless Individual stock chart and overall Index Stock Markets: Without clear trends, it will affect the responsiveness of the Pentagon Guider® System in plotting the RED and GREEN Pentagon indicators.
- Increased Signal Noise: Increased noise/randomness in daily or weekly timeframes complicates analysis in trendless conditions.
- Stock charts that have Insufficient Volume: Example, trading with continuous bar of zero volume will give raise to inaccurate Pentagon Guider® System indicators.
- Stock charts with less than 6 months period of trading bars - provide insufficient data for Pentagon Guider® System Algorithm to compute/calculate.

SMARTRobie® also employs sentiment analysis for news headlines to enhance decision-making, making it more robust and relevant for Users.

### **14.0 Risk Disclosures**

Stock Market Adaptability Risk: Pentagon Guider® System will have limitation to adapt quickly to sudden, non-trend-based stock market movements, which could lead to potential losses.

### **15.0 Direct Charges (Credit Points)**

Upon successful account creation, Users will receive complimentary 100 credit points. Each usage will deduct 2 credit points or depends on the SMARTRobie® features. If Users need additional usage, they can extend their subscription for RM9.90 per month, subject to charging rate changes based on business needs. Free usage is on public holiday and weekend (Saturday and Sunday).
